RESOLUTION RATIFYING THE CONTRACT FOR FENCING OF BUREAU OF FISHERY COMPOUND, PERIMETER AND COMPLETION OF CHB FISH POND WALL, BAYSIDE, SANTO ANGEL CENTRAL, SANTA CRUZ, LAGUNA IN THE AMOUNT OF THREE HUNDRED EIGHTY THOUSAND THREE HUNDRED FIFTY ONE PESOS (P380,351.00)
