A RESOLUTION ADOPTING AND CREATING THE PUBLIC FINANCIAL MANAGEMENT TEAM TO SPEARHEAD IN THE IMPLEMENTATION OF PUBLIC FINANCIAL MANAGEMENT TOOL(PFMT) FOR THE LOCAL GOVERNMENT UNITS AS A REQUIREMENT OF THE DEPARTMENT OF BUDGET AND MANAGEMENT FOR THE RELEASE OF FUNDING SUPPORT FROM LOCAL GOVERNMENT SUPPORT FUND (LGSF) OF THIS MUNICIPALITY.

WHEREAS, pursuant to section 3(b) of the 1991 Local Government Code requires the establishment of every Local Government Unit of an accountable, efficient and dynamic organizational structure and operating mechanism that will meet the priority needs requirements of its community;

WHEREAS, the Department of Budget and Management as a requirement for the release of any financial support to LGU's needs to organize and prescribe the use of Public Financial Management Assessment Tool (PFMAT) as a measure institutionalizing the governance reforms through timely PGM assessments and improvement planning exercises;

WHEREAS, PFMAT for LGU's is a self assessment, evidence based instrument which describes the characteristics of an open and orderly PFM system that will help to identify the strengths and weaknesses as basis for improvement measures;
