A RESOLUTION RESPECTFULLY AND EARNESTLY REQUESTING FINANCIAL ASSISTANCE TO HONORABLE CONGRESSWOMAN MARIA JAMINA KATHERINE B. AGARAO-OLOROSO OF THE 4TH DISTRICT OF LAGUNA TO CONSIDER AND CAUSE IMMEDIATE ALLOCATION OF FUNDS FOR THE REHABILITATION, CONSTRUCTION AND IMPROVEMENT OF THE OLD MUNICIPAL BUILDING OF SANTA CRUZ, LAGUNA, THE MUNICIPAL RURAL HEALTH OFFICE AND OTHER HEALTH FACILITIES IN THE MUNICIPALITY OF SANTA CRUZ, PROVINCE OF LAGUNA

WHEREAS, Section 17(3) of the Local Government Code mandates the Local Government Unit (LGU) to exercise power and discharge such other functions and responsibilities of national agencies and offices devolved to them as are necessary appropriate or incidental to the efficient and effective governance such as providing their constituents the basic services and facilities;

WHEREAS, one of the priority development thrusts of the Municipal Government of Santa Cruz, Laguna is to promote the health, safety and wellness of its constituents especially the poor or those included below the poverty level;

WHEREAS, there is an immediate need for the improvement and rehabilitation of our Municipal Building, including the Municipal Health Office and other Health Facilities not only because they are considered as one of the remaining heritage structures that need to be preserved because of cultural and historical value but also because of the safety and integrity of the old structure maybe compromised as it caters everyday to a large number of people belonging to the local community and nearby towns for its services and other functions;

WHEREAS, the Municipality of Santa Cruz desires to implement the local priority project congruent with the socio-economic and development agenda of the present administration but lacks the financial capability to implement the aforementioned project;

WHEREAS, this LGU through its Sanggunian, and upon the motion of Hon. Norman " Trophy" T. Tolentino, deemed it necessary to source out funds, hence this request;
