**RESOLUTION NO. 269-S2023**

**A RESOLUTION GRANTING AUTHORITY TO HONORABLE MAYOR EDGAR S. SAN LUIS TO ENTER AND SIGN A MEMORANDUM OF AGREEMENT (MOA) FOR AND IN BEHALF OF THE MUNICIPAL GOVERNMENT OF SANTA CRUZ, LAGUNA WITH NATIONAL FOOD AUTHORITY (NFA) DULY REPRESENTED BY ITS REGION IV GENERAL MANAGER PIOLITO C. SANTOS WITH PRINCIPAL OFFICE AT VISAYAS AVENUE, BARANGAY VASRA, DILIMAN, QUEZON CITY FOR THE PURPOSE OF ADOPTING A PROGRAM DUBBED AS THE PALAYMARKETING ASSISTANCE PROGRAM FOR LEGISLATORS AND LOCAL GOVERNMENT UNITS (PALLGU) IN ORDER TO PROVIDE OPPORTUNITY FOR THE LGU'S AND THE LEGISLATORS TO SERVE THEIR FARMER CONSTITUENTS TO MAXIMIZE THEIR INCOME.**

**WHEREAS**, the National Food Authority (NFA) pursuant to Republic Act 11203 is mandated by law under Rice Tariffication Law which shall procure palay solely from local farmers;

**WHEREAS**, there is a need for the Local Government Unit to enter into Memorandum of Agreement in order to undertake and to provide premium price of at least an amount determined by the legislator/LGU using as reference the prevailing market price to be added to the existing NFA support price for the purchase of palay from Farmers Organization / Farmers Cooperative under their area of jurisdiction;

**WHEREAS**, on March 21, 2023, the Honorable members of the Sangguniang Bayan through the Honorable Vice Mayor received an endorsement requesting to grant the Honorable Mayor Edgar S. San Luis to enter into MOA with NFA for adoption of the Palay Marketing Assistance Program for Legislators and Local Government Units (PALLGU) with the following obligation to mention :

1. Before its commencement the LGU shall submit a Letter of Intent (LOI) to NFA indicating the following details:
  - a. Premium amount offered per kg of palay
  - b. Volume of palay to be purchase
  - c. Area where the palay will be purchased and stored
2. The approval of LOI shall furnish the NFA a masterlist of farmer beneficiaries and disbursed the exact amount as proposed in the LOI
3. The LGU shall inform the farmers beneficiaries to deliver the palay at NFA buying station

**WHEREAS**, the endorsement was referred to the Committee on Agriculture Fisheries and Cooperative for study;

**WHEREAS**, after careful evaluation of the Committee it was recommended for its approval;

**NOW THEREFORE** on motion of Hon. Alan T. Pamatmat ( Vice Chairman of Committee on Agriculture, Fisheries and Cooperative), duly seconded by Hon. Ambiel John C. Panganiban, Hon. Esmeraldo C.
