RESOLUTION GRANTING AUTHORITY TO HONORABLE MAYOR EDGAR S. SAN LUIS TO ENTER FOR AND IN BEHALF OF THE MUNICIPAL GOVERNMENT OF SANTA CRUZ, LAGUNA INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE COAST GUARD DISTRICT NATIONAL CAPITAL REGION-CENTRAL LUZON HEREIN REPRESENTED BY COAST GUARD REAR ADMIRAL HOSTILLO ARTURO E. CORNELIO, DISTRICT COMMANDER, FOR THE USE OF IT'S COMMUNITY FISH LANDING CENTER IN BARANGAY GATID OCCUPYING MORE OR LESS FIFTEEN (15) SQUARE METER, A MULTI-PURPOSE AREA FOR PCG'S HOSTING OF STATION AND PERSONNEL IN SANTA CRUZ, LAGUNA.

WHEREAS, the first endorsement dated October 13, 2022 by Mr. Melvin O Bonza with the authority of the Honorable Mayor **Edgar S. San Luis** to the Honorable members of Sangguniang Bayan requesting to grant authority to sign a Memorandum of Agreement with the Philippine Coast Guard where the Philippine Coast Guard and the second endorsement attached is the final copy of the MOA dated March 10, 2023;

WHEREAS, the Municipal Government of Santa Cruz, Laguna recognizes the value of having their presence in patrolling, enforcing the Maritime Law and keeping the peace and order of the coastal area within its territorial jurisdiction;

WHEREAS, in the pursuit of achieving- protecting the general welfare and its community as well as preserving the environment, is requesting a parcel of land sufficient and suitable for hosting PCG's Station and Personnel measuring more or less fifteen (15) square meter located at the Community Landing Center in Barangay Gatid, Santa Cruz, Laguna which will serve as the multi-purpose area of PCG as long as the site is still available shall be no less than 10 years from the signing of this MOA. The PCG guarantees that the site will be exclusively used to PCG's functions and operations upon mutual agreement of parties;

WHEREAS, said request was referred to Sangguniang Bayan Committee on Natural Resources and Environment for review and study;

WHEREAS, after thorough evaluation said request is recommended for its approval;

NOW THEREFORE, on motion of Hon. Mark Anthony P. Joven, (Chairman, Committee on Natural Resources and Environment, duly seconded by all the members of the Sangguniang Bayan present, it was
