RESOLVED: To ratify the contract of this project through public bidding for the:

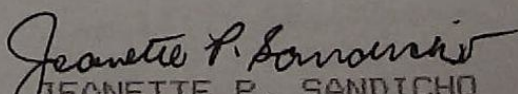
Construction of Playground at Barangay

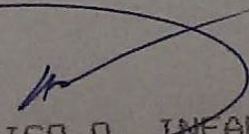

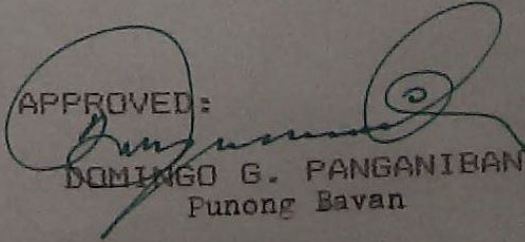
