RESOLUTION NO. 092-S'97

RESOLUTION REALIGNING THE ITEM EXTRA-ORDINARY MISCELLANEOUS EXPENSES OF THE OFFICE OF THE SANGGUNIANG BAYAN AND OFFICE OF THE VICE MAYOR TO THE ITEM OF OTHER SERVICES IN THE MAOUNT OF TWWO HUNBDRED THOUSAND (P200,000.00) AND EIGHTHY THOUSAND PESOS (P80,000.00) RESPECTIVELY AND AN ADDITIONAL ITEM OF GRANTS-IN-AIDS AND CONTRIBUTION IN THE AMOUNT OF TEN THOUSAND PESOS (P10,000.00).

WHEREAS, as provided for in the Government Accounting and Auditing Manual (GAAM) Sec. 365 of Vol. II page 174, the item Extra-Ordinary & Miscellaneous Expenses is only allowed in the Office of the Local Chief Executive, hence not provided for in the Legislative Branch of Government (refer to GAAM);

WHEREAS, in order to achieve the needs of the constituents and to carry out Barangay Projects, Sports Development Programs, Social and Cultural Programs and Clean and Green Projects.

WHEREAS, the amount of P10,000.00 which was funded under the Item of Other Services will be transferred to the Item Grants-In-Aids and Contribution under the Budget of the Office of the Vice Mayor.

NOW, THEREFORE, on motion of Hon. Louie C. de Leon duly seconded by Hon. Councilors Angelito U. Limjuco, Celestino D. Pamatmat and Bernardo E. Ison and with the consent of all members of the Sang. Bayan, it was

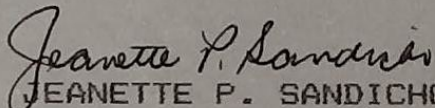

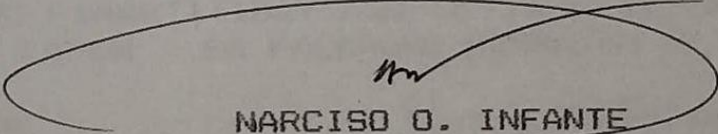

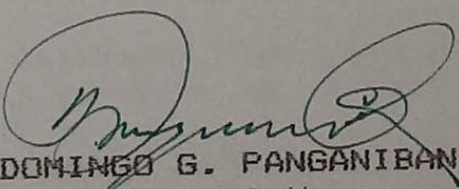
