RESOLUTION NO. 284-S'99

RESOLUTION REQUESTING THE HONORABLE RONALDO B. ZAMORA,
CHAIRMAN, OVERSIGHT COMMITTEE ON DEVOLUTION, TO ENDORSE THE
PROJECT ENTITLED CONSTRUCTION OF FARM-TO-MARKET ROAD AT
BARANGAY PATIMBAO AND BARANGAY PALASAN IN THE AMOUNT OF
P1,813,000.00 AND CONCRETING OF BARANGAY ROAD AT BARANGAY
PATIMBAO IN THE AMOUNT OF P2,271,000.00, BOTH IN SANTA CRUZ,
LAGUNA FOR FUNDING SUPPORT UNDER THE LOCAL GOVERNMENT
SERVICE EQUALIZATION FUND (LGSEF).

WHEREAS, R. A. 7160, otherwise known as the Local
Government Code of 1991, delegated specific functions and
responsibilities to Local Government Units (LGUs) particularly
on the effective and efficient delivery of basic services and
facilities at the local level;

WHEREAS, there is an urgent need to provide fund
assistance to LGUs in order to alleviate their financial
burdens in carrying out the devolved functions and
responsibilities, as specified by the Code;

WHEREAS, Executive Order No. 48, Series of 1998,
established a Program for Devolution Adjustment and
Equalization Fund, renamed as Local Government Service
Equalization Fund (LGSEF), which is primarily aimed at
enhancing the capacities of LGUs to fully and effectively
exercise their devolved functions, services and facilities;

WHEREAS, Santa Cruz, Laguna desires to implement the
project, entitled Construction of Farm to Market Road at
Barangay Patimbao and Barangay Palasan in the amount of
P1,813,000.00 and Concreting of Barangay Road at Barangay
Patimbao in the amount of P2,271.00 which are local priority
projects congruent with the socio-economic and development
agenda of the Estrada Administration;

WHEREAS, Santa Cruz, Laguna lacks the financial
capability to implement the aforementioned project;


NOW, THEREFORE, on motion of Hon. Coun. Louie C. de
Leon, duly seconded by the Hon. Jaime Alexander T. Calupitan
and unanimous approval of all the members present, it

RESOLVED: To request the Honorable Ronaldo Zamora, Chairman Oversight Committee on Devolution to endorse the project entitled Construction of Farm to Market Road at Barangay Patimbao and Barangay Palasan in the amount of 1,813,000.00 and Concreting of Barangay Road at Barangay Patimbao in the amount of P2,271,000.00, both in Santa Cruz, Laguna, for funding support under the Local Government Service Equalization Fund (LGSEF).


