A RESOLUTION AUTHORIZING HONORABLE MAYOR EDGAR S. SAN LUIS IN BEHALF OF THE MUNICIPAL GOVERNMENT OF SANTA CRUZ, LAGUNA TO RECEIVE THE PROVISION OF FUNDS (FINANCIAL ASSISTANCE) FROM THE LOCAL GOVERNMENT SUPPORT FUND – FUND ASSISTANCE (LGSF-FA) OF THE DEPARTMENT OF BUDGET AND MANAGEMENT (DBM) FOR THE PROJECT “CONSTRUCTION OF MUNICIPAL HALL BUILDING WITH RETROFITTING OF OLD MUNICIPAL BUILDING AND PARKING AREA” THIS MUNICIPALITY.

WHEREAS, for the consideration of the Honorable Body is the request of the Honorable Mayor Edgar S. San Luis dated February 10, 2023, authorizing in behalf of the Municipal Government of Santa Cruz, Laguna to receive financial assistance (provision of funds) for the project “CONSTRUCTION OF MUNICIPAL BUILDING WITH RETROFITTING OF OLD MUNICIPAL HALL BUILDING AND PARKING AREA” and the fund assistance is in accordance to LBC No. 142 dated January 2022;

WHEREAS, there is a need to construct and retrofit said dilapidated building for the protection and safety of Municipal employees occupying the building and most importantly the LGU lacks sufficient fund to implement its project;
