AN ORDINANCE APPROVING THE SUPPLEMENTAL BUDGET IN THE AMOUNT OF FOUR MILLION ONE HUNDRED SIXTY FOUR THOUSAND THREE HUNDRED THIRTY ONE PESOS AND SIXTY CENTAVOS (P4,164,331.60) FROM THE 2022 SURPLUS IN THE AMOUNT OF Php19,164,331.60 WHICH SHALL BE USED TO ALLOCATE FUNDS IN THE OFFICE OF THE MAYOR, LOYALTY PAY (Php 1,895,000.00); FOOD SUPPLIES EXPENSES (Php1,000,000.00); OTHER SUPPLIES AND MATERIAL EXPENSES (Php 1,000,000.00); TRAINING AND SEMINAR EXPENSES (Php 269,331.60) SUBJECT TO APPLICABLE LAWS AND AUDITING RULES AND PROCEDURES.

WHEREAS, an endorsement from Honorable Mayor Edgar S. San Luis dated July 3, 2023 is requesting for Supplemental Budget in the amount of Php4,164,331.60 from 2022 Surplus with a total amount of Php19,164,331.60 to be allocated to the following:
