RESOLUTION NO. 347-S2023

A RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE EDGAR S. SAN LUIS TO ENTER AND SIGN A CONTRACT OF LEASE WITH J BROS REALTY DEVELOPMENT CORPORATION REPRESENTED BY ENGR. JESUSITO LEGASPI, OWNER OF THE PROPERTY LOCATED IN BRGY. PAGSAWITAN, SANTA CRUZ, LAGUNA TO BE USED FOR GOVERNMENT SERVICE WHICH INCLUDES AMONG OTHERS HOUSING THE OFFICE FOR THE BUREAU OF FIRE PROTECTION AND OTHER NATIONAL AND LOCAL GOVERNMENT OFFICES WITH A MONTHLY RENTAL OF P50,000.00.

WHEREAS, the Hon. Mayor Edgar S. San Luis endorsed to the Sangguniang Bayan for the issuance of a resolution granting him an authority to enter and sign a Contract of Lease with the J Bros Realty Development Corporation;

WHEREAS, the said endorsement was referred to the Committee on Laws and Ordinance and Committee on Budget, Finance and Appropriation for its discussion and deliberation;

WHEREAS, it was recommended for approval knowing that the Contract of Lease is a renewal of the previous one.


