**RESOLUTION NO. 364-S2023**

**A RESOLUTION AUTHORIZING THE HON. MAYOR EDGAR S. SAN LUIS TO ENTER AND SIGN A MEMORANDUM OF AGREEMENT, FOR AND IN BEHALF OF THE MUNICIPAL GOVERNMENT OF SANTA CRUZ, LAGUNA WITH THE DEPARTMENT OF HEALTH TREATMENT REHABILITATION CENTER –BICUTAN WHICH SHALL GOVERN THE REFERRAL OR ADMISSION FOR TREATMENT OF DRUG DEPENDENTS REFERRED BY THIS MUNICIPALITY TO THE BICUTAN REHABILITATION CENTER.**

**WHEREAS**, under Section 75 of Republic Act 9165 (Comprehensive Dangerous Drugs Act of 2002), the Dangerous Drugs Board, in coordination with the Department of Health (DOH) is tasked to oversee and monitor the Integration, Coordination and Supervision of all drug rehabilitation, intervention, after-care and follow up programs, projects and activities, as well as the establishments, operations, maintenance and management of privately –owned drug treatment rehabilitation centers;

**WHEREAS**, under Section 51 of Republic Act 9165, Local Government Units are required to appropriate a substantial portion of their respective annual budgets to assist in or enhance the enforcement of the ACT giving priority to preventive or educational programs and the rehabilitation or treatment of drug dependents;

**WHEREAS**, the said Memorandum of Agreement is a requirement for the accreditation of the community-based Drug Program of Santa Cruz, Laguna.

**NOW THEREFORE**, on motion of Hon. Esmeraldo C. De Las Armas, Jr. ( Chairman of Committee on Health, Nutrition and Sanitation), duly seconded by Hon. Patrocinia S. Kalaw and Hon. Ambiel John C. Panganiban and with the approval of the members of the Sangguniang Bayan, it was

**RESOLVED:** Authorizing the Hon. Mayor Edgar S. San Luis to Enter and Sign a Memorandum of Agreement, for and in behalf of the Municipal Government of Santa Cruz, Laguna with the Department of Health Treatment Rehabilitation Center –Bicutan which shall Govern the Referral or Admission for Treatment of Drug Dependents Referred by this Municipality to the Bicutan Rehabilitation Center.


