RESOLUTION NO. 369-S2023

A RESOLUTION AUTHORIZING THE HONORABLE MAYOR EDGAR S. SAN LUIS TO ENTER AND SIGN A MEMORANDUM OF AGREEMENT FOR AND IN BEHALF OF THE MUNICIPALITY OF SANTA CRUZ, LAGUNA WITH RHENZ EMILLE FUNERAL PARLOR DULY REPRESENTED BY EMILIA T. BALUBAYAN AND MICHELLE T. BALUBAYAN AS SERVICE PROVIDER FOR THE MANAGEMENT OF HUMAN REMAINS FOR ALL CASES THAT WILL BE REFERRED BY THE MUNICIPALITY.

WHEREAS, the Municipal Government of Santa Cruz, Laguna through the MDRRMO is directed to forge agreements in the private sector that will ensure adequate supply of goods, medicines, necessary service/s, and immediate use of facilities and resources during and in the aftermath of a disaster, calamity or communicable disease;

WHEREAS, the previous Memorandum of Agreement with the said service provider which covered the management of human remains of Covid 19 related cases was automatically terminated when President Ferdinand R. Marcos, Jr. lifted the Public Health Emergency last July 22, 2023;

WHEREAS, the service provider commits and agrees to provide services for the management of human remains of all cases that will be referred by the municipality, whether infectious or non-infectious, non-Covid or Covid related cases;

WHEREAS, the municipality agrees to pay the services delivered by the service provider in the amount of P35,000 00 for every service rendered, inclusive of all applicable taxes,

WHEREAS, after careful study and evaluation the Sangguniang Bayan deemed it proper to grant an authority to the Hon. Mayor Edgar S. San Luis to enter into a Memorandum of Agreement with the aforementioned service provider.

NOW THEREFORE, on motion of Hon. Lea A. Almarvez (Chairman of Committee on Social Welfare and Development, Family and Women), duly seconded by Hon. Lucena R. Odejar, Hon. Patrocinia S. Kalaw, Hon. Esmeraldo C. De Las Armas, Jr. and Hon. Ambiel John C. Panganiban, and with the approval of the Sangguniang Bayan members, it was

RESOLVED: To authorize the Honorable Mayor Edgar S. San Luis to enter and sign a Memorandum of Agreement for and in behalf of the Municipality of Santa Cruz, Laguna with Rhenz Emille Funeral Parlor duly represented by Emilia T. Balubayan and Michelle T. Balubayan as service provider for the management of human remains for all cases that will be referred by the municipality

ORDERED: Let the copy of this resolution be furnished the Hon. Mayor, the Municipal Budget Officer, the Municipal Accountant, the Municipal Treasurer, Rhenz Emille Funeral Parlor and other concerned offices, all this municipality, for their information and appropriate action.
