**RESOLUTION NO. 381-S2023**

**A RESOLUTION AUTHORIZING THE HON. MAYOR EDGAR S. SAN LUIS TO ENTER INTO AND SIGN ON BEHALF OF THE MUNICIPAL GOVERNMENT OF SANTA CRUZ, LAGUNA THE SUPPLEMENTARY AGREEMENT TO THE UNIFIED MEMORANDUM OF AGREEMENT BETWEEN THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT (DSWD) AND LOCAL GOVERNMENT UNIT (LGU) OF SANTA CRUZ, LAGUNA REGARDING THE DETAILS OF THE IMPLEMENTATION ARRANGEMENTS FOR THE PANTAWID PAMILYANG PILIPINO PROGRAM (4Ps) IN THIS MUNICIPALITY.**

**WHEREAS**, presented for consideration of the august body is an endorsement from the Hon. Edgar S. San Luis for an issuance of a resolution granting him the authority to enter and sign the Supplementary Agreement to the Unified Memorandum of Agreement with the Department of Social Welfare and Development (DSWD), as aforementioned above;

**WHEREAS**, in adherence to Republic Act 11310 – An Act Institutionalizing the Pantawid Pamilyang Pilipino Program (4Ps), DSWD and Partner Local Government Units are enjoined to have clear and targeted programs for the beneficiaries ensuring that their well-being is improved and they do not slide back to poverty;

**WHEREAS**, said endorsement was referred and deliberated by the members of the joint committees on Health, Nutrition and Sanitation; Social Welfare and Development, Family and Women, and Laws and Ordinance of this sanggunian;

**WHEREAS**, after the discussion this body found it advantageous to strengthen the partnership, and ensure effective implementation for the Pantawid Pamilyang Pilipino Program (4Ps) in this municipality, as indicated

**NOW THEREFORE**, on motion of Honorable Esmeraldo C. De Las Armas, Jr. ( Chairman of Committee on Health, Nutrition and Sanitation ), duly seconded by Hon. Norman T. Tolentino, Hon. Ambiel John C. Panganiban, Hon. Lucena R. Odejar, Hon. Patrocinia S. Kalaw and Hon. Regine S. Regalado and with the approval of the members of the Sangguniang Bayan present it was,


