**RESOLUTION NO. 373-S2023**

**RESOLUTION ADOPTING THE FORMULATION AND IMPLEMENTATION OF THE LOCAL DISASTER RISK REDUCTION AND MANAGEMENT PLAN FOR THE PERIOD 2023-2025 OF THE MUNICIPAL GOVERNMENT OF SANTA CRUZ, LAGUNA SUBJECT TO APPLICABLE LAWS, RULES AND REGULATION.**

**WHEREAS**, pursuant to Section 4 of Republic Act 10121 or the Philippine Disaster Risk and Reduction and Management Act of 2010, there is a need to provide for the development of policies and plans and the implementation of actions and measures pertaining to all aspects of Disaster Risk Reduction and Management, including good governance, risk assessment and early warning, knowledge building and awareness revising, reducing underlying risk factors, and preparedness for effective response and early recovery;

**WHEREAS**, the Municipality of Santa Cruz, Laguna had crafted a Comprehensive LRMM Plan for the years 2023-2025 through its combined experiences and expertise, the help of national agency counterparts, support of local and internal NGO's, the assistance of constant supports, which includes programs, projects and activities that have emphasis on the Disaster Prevention and Mitigation, Preparedness, Response and Rehabilitation and Recovery;

**WHEREAS**, the LDRRM Plan of the Municipality of Santa Cruz, Laguna envisions a safe, adaptive and disaster - resilient community towards sustainable development;

**WHEREAS**, on July 03, 2023, an endorsement was forwarded to the Honorable Sangguniang Bayan for appropriate action the Local Disaster Risk Reduction and Management Plan for the period 2023-2025 and of the Municipality of Santa Cruz, Laguna;

**WHEREAS**, said endorsement was referred to the Committee on Environment and Natural Resources for study and evaluation;

**WHEREAS**, after due evaluation and deliberation, it is hereby recommended by the committee for its approval;
