WHEREAS, Hon. Ambiel John C. Panganiban requested the august body to recognize Misha Ann and her accomplishment as a dancer.


NOW THEREFORE, on motion of Honorable Lea A. Almarvez (Chairman of Committee on Education and Culture), duly seconded by all the members present, it was


