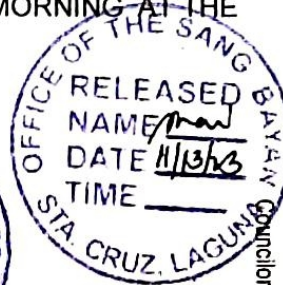

**RESOLUTION NO. 372-S2023**

**RESOLUTION APPROVING THE RELOCATION AND RESETTLEMENT PLAN (RRAP) FOR 2023-2028 OF THE MUNICIPALITY OF SANTA CRUZ, LAGUNA.**

**WHEREAS**, one of the flagship social programs of the national and local governments is the Socialized Housing for the under privileged, informal and/or displaced settlers, vulnerable and the urban poor sector. As mandated by Republic Act No. 7160 known as the Local Government Code of 1991 and the Urban Development in Housing Act (UDHA) of 1992 of RA 7279, the local government is required to prepare a Local Shelter Plan which clearly define the present and projected needs, gaps, issues on local housing with regard with the projected population, plan resources required, affordability analysis which are basis for drawing up the strategies, interventions and implementation plan of the local housing program.

**WHEREAS**, presented for consideration of the Body is the Relocation and Resettlement Action Plan (RRAP) of the Municipality of Santa Cruz Laguna for CY 2023-2028 based on the approved Local Shelter Plan 2014-2023 which will bring not only the much sought socio-economic gains for the municipality, but also to achieve the desired vision for the general welfare and to achieve the objectives of reducing the number of informal settlers and preventing the formation of new resettlements.

**WHEREAS**, enumerated in the Relocation and Resettlement Action Plan (RRAP) is the Master List of Beneficiaries in: 1) Lupang Katuparan Village I, Barangay Calios (218 households); 2) Lupang Katuparan Village II, Barangay Oogong (239 households); 3) Sitio Bayside, Barangay Gatid (166 households); and 4) Sitio Pantalan, Barangay San Pablo Norte (55 households);
