MUNICIPAL ORDINANCE NO. 13-S2023

AN ORDINANCE AUTHORIZING THE TEMPORARY CLOSURE OF PORTIONS OF CAILLES STREET FROM THE SANTA CRUZ BRIDGE TO THE FRONT OF THE MUNICIPAL HALL; J. P. RIZAL STREET (FRONT OF ESCOLAPIA BUILDING) AND M. H. DEL PILAR STREET IN FRONT OF MEGA TO THE BACK OF JOLLIBEE FROM NOVEMBER 20, 2023 TO JANUARY 6, 2024 FOR THE PURPOSE OF CONDUCTING NIGHT MARKET.

WHEREAS, the Sangguniang Bayan is empowered to temporarily close roads or alleys pursuant to Section 21 (a) (c) of the Local Government Code of 1991;

WHEREAS, on November 07, 2023 Sangguniang Bayan Office received a letter from Hon. Mayor Edgar S. San Luis recommending the schedule for Night Market from November 20, 2023 to January 06, 2024 to start putting up of goods from 6:00 in the evening to 12:00 midnight;

WHEREAS, the request letter was referred to the Committee on Transportation and Communication for study;

WHEREAS, after consultation and deliberation the same was recommended for its approval;

NOW THEREFORE, on motion of Hon. Ambiel John C. Panganiban, (Chairman Committee on Transportation and Communication), duly seconded by Hon. Norman T. Tolentino, Hon. Alan T. Pamatmat and Hon. Lucena R. Odejar, and with the approval of the members of the Sangguniang Bayan present, it was

Be it ordained by the Sangguniang Bayan of Santa Cruz Laguna in its regular session assembled, that:

SECTION 1. Portion of Cailles Street shall be closed from Santa Cruz Bridge to the front of the Municipal Hall; J. P. Rizal Street (front of Escolapia Building) and M. H. Del Pilar Street in front of Mega to the back of Jollibee for the purpose of conducting Night Market.

SECTION 2. The temporary closure shall start from November 20, 2023 – January 06, 2024, from 6:00 in the evening to 12: 00 midnight.

SECTION 3. The following conditions shall be implemented:

- That a substitute route shall be provided with corresponding plan
- That the alternate route shall be properly maintained for public safety until such duration
- That the Office of the Municipal Administrator shall provide appropriate traffic and public information signages and manpower coordination with the SCTMO and the PNP and other appropriate agencies of the government.
