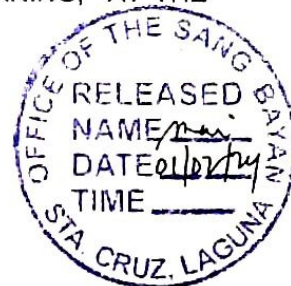

### RESOLUTION NO. 417-S2023

**A RESOLUTION GRANTING AN AUTHORITY TO HON. MAYOR EDGAR S. SAN LUIS FOR AND ON BEHALF OF THE LOCAL GOVERNMENT UNIT OF SANTA CRUZ, LAGUNA TO SIGN A MEMORANDUM OF AGREEMENT WITH THE COALITION ALLIANCE OF FARMERS IN THIS MUNICIPALITY.**

**WHEREAS**, the Municipal Administrator by the authority of the Municipal Mayor, sent said endorsement of this august body;

**WHEREAS**, it was referred to the Committee on Agriculture, Fisheries and Cooperatives and the Committee on Laws and Ordinances for study;

**WHEREAS**, the Memorandum of Agreement supports the government's implementation of the project "Rice Processing System 1" under the Rice Competitiveness, Enhancement Fund (RCEF) Mechanization program which Philmech earlier transferred to the municipality a Rice Processing System (RPS) 1 facility;

**WHEREAS**, the Memorandum of Agreement supports the provision of seed money of the Local Government Unit (LGU) in the amount of P2,000,000.00 as revolving fund that limits its use in the buying and selling of palay which shall be managed by the Coalition of Farmers in Santa Cruz, Laguna.

**NOW THEREFORE**, on motion of Honorable Norman T. Tolentino (Chairman of Committee on Agriculture, Fisheries and Cooperatives), duly seconded by Hon. Lucena R. Odejar, Hon. Ambiel John C. Panganiban, and Hon. Esmeraldo C. De Las Armas, Jr. and with the approval of the members of the Sangguniang Bayan, it was
