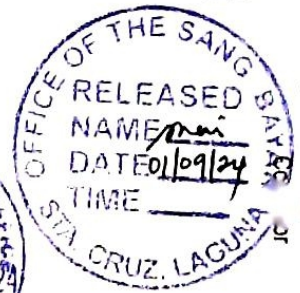

MUNICIPAL ORDINANCE NO. 14-S2023

AN ORDINANCE AUTHORIZING THE TEMPORARY CLOSURE OF ONE SIDE OF LOPEZ JAENA STREET FROM DECEMBER 11, 2023 TO JANUARY 6, 2024 FOR THE PURPOSE OF OPERATING AMUSEMENT GAMES AND RIDES IN THE SPECIFIED LOCATION.

WHEREAS, the Sangguniang Bayan is empowered to temporarily close roads or alleys pursuant to Section 21 (a) (c) of the Local Government Code of 1991;

WHEREAS, the Municipal Administrator authorized by the Hon. Mayor Edgar S. San Luis sent a letter to the Sangguniang Bayan regarding the aforementioned request;

WHEREAS, the request letter was referred to the Committee on Games and Amusement and Committee on Transportation and Communication for study;

WHEREAS, during the deliberation in the committee, it came out that the request was a concept of the Santa Cruz Market Vendors Credit Cooperative to stir economic activity and foster the spirit of the Yuletide season.

NOW THEREFORE on motion of Hon. Lucena R. Odejar (Chairman of Committee on Games and Amusement), seconded by Hon. Ambiel John C. Panganiban and Hon. Norman T. Tolentino and with the approval of the members of the Sangguniang Bayan, it was

Be it ordained by the Sangguniang Bayan in its regular session assembled that:

SECTION 1. Portion of Lopez Jaena Street shall be closed for the purpose of operating amusement games and rides in a specified location.

SECTION 2. The temporary closure shall start from December 11, 2023 to January 6, 2024.

SECTION 3. The Office of the Municipal Administrator shall provide appropriate traffic and public information signages and manpower coordination with the Sta. Cruz Traffic Management Office (SCTMO) and the Philippine National Police (PNP) and other appropriate agencies of the government.

SECTION 4 Pursuant to the above conditions, the temporary closure of portions of streets for the purpose of operating amusement games and rides is hereby approved.

SECTION 5. This ordinance shall take effect immediately upon its approval

ORDERED: Let copies of this ordinance be furnished the Honorable Sangguniang Panlalawigan, the Honorable Municipal Mayor, the Municipal Treasurer, the Municipal Engineer, the Market Supervisor, SCTMO, PNP, Santa Cruz Market Vendors Credit Cooperative, and other concerned offices, for their information and appropriate action.
