A RESOLUTION AUTHORIZING THE HON. EDGAR S. SAN LUIS ON BEHALF OF THE MUNICIPAL GOVERNMENT OF SANTA CRUZ, LAGUNA TO ENTER AND SIGN A TRIPARTITE MEMORANDUM OF AGREEMENT AMONG THE MUNICIPAL GOVERNMENT OF SANTA CRUZ, LAGUNA, THE UNIVERSITY OF LOS BAÑOS (UPLB) LAGUNA COLLEGE OF HUMAN ECOLOGY, DEPARTMENT OF COMMUNITY AND ENVIRONMENT RESOURCE PLANNING (DECERP-CHE) AND THE DEPARTMENT OF HUMAN SETTLEMENTS AND URBAN DEVELOPMENT (DHSUD) FOR THE MUNICIPALITY TO BE INCLUDED IN THE TECHNICAL ASSISTANCE PROGRAM ON HUMAN SETTLEMENTS PLANNING (TAP-HSP).

WHEREAS, with the letter from the Municipal Planning and Development Coordinator (MDPC), the Municipal Administrator as authorized by the Municipal Mayor endorsed to this august body the above-quoted subject;

WHEREAS, said endorsement was referred to the Committee on Housing and Land Use, where it was thoroughly discussed, particularly its advantages to the municipality in crafting the Climate and Disaster Risk Assessment (CDRA) and Comprehensive Land Use Plan (CLUP), thus it is recommended for approval;

NOW THEREFORE, on motion of Hon. Lucena R. Odejar (Chairman of the Committee on Housing and Land Use), duly seconded by Hon. Norman T. Tolentino and Hon. Ambiel John C. Panganiban and with the approval of the members of the Sangguniang Bayan, it was

San Luis on behalf of the Municipal Government of Santa Cruz, Laguna to enter and sign a Tripartite Memorandum of Agreement among the Municipal Government of Santa Cruz, Laguna, the University of the Philippines, Los Baños (UPLB) Laguna College of Human Ecology, Department of Community and Environment Resource Planning (DECERP-CHE) and the Department of Human Settlements and Urban Development (DHSUD) for the municipality to be included in the Technical Assistance Program on Human Settlements Planning (TAP-HSP).
