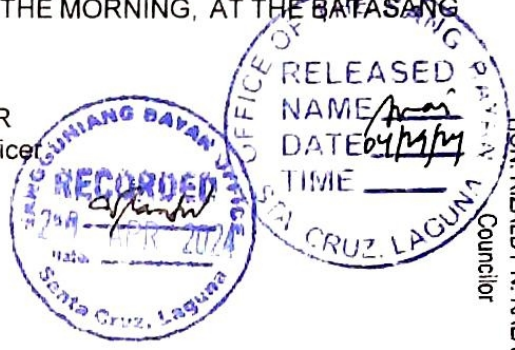

RESOLUTION NO. 236-S2024

A RESOLUTION GRANTING AUTHORITY TO HON. EDGAR S. SAN LUIS ON BEHALF OF THE MUNICIPAL GOVERNMENT OF SANTA CRUZ, LAGUNA TO SIGN A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT (DSWD) THROUGH ITS REGIONAL OFFICE IV-A FOR THE TRANSFER OF FUND (TOF) FOR THE STIPEND OF SOCIAL PENSIONERS (NATIONAL) TO EXPEDITE THE SEMESTRAL DISTRIBUTION OF SAID STIPEND.

WHEREAS, the Hon. Mayor endorsed said request to the Hon. Sangguniang Bayan for its consideration and referred to the Committee on Social Welfare and Development, Family and Women for discussion;

WHEREAS, the Social Pension Program for Indigent Senior Citizens continuously implements the Cash Payout through the Transfer of Fund (TOF) to Local Government Units since it is one of the most efficient service deliveries for the past years;

WHEREAS, Republic Act No. 11916 which aims to maximize the contribution of Senior Citizens to nation building, grant- benefits, special privileges and other purposes, the Indigent Senior Citizens shall be entitled to a monthly stipend amounting to not less than One Thousand Pesos (P1,000.00) to augment their daily subsistence and other medical needs.

WHEREFORE, on motion of Hon. Lea A. Almarvez (Chairman of Committee on Social Welfare and Development, Family and Women), duly seconded by all the members of the Sangguniang Bayan, it was,

RESOLVED: To grant authority to Hon. Edgar S. San Luis on behalf of the Municipal Government Of Santa Cruz, Laguna to sign a Memorandum Of Agreement with the Department Of Social Welfare And Development (DSWD) through its Regional Office IV-A for the Transfer Of Fund (TOF) for the stipend of social pensioners (National) to expedite the semestral distribution of said stipend.

ORDERED: Let copies of this resolution be furnished the Honorable Mayor, the Municipal Social Welfare and Development Officer, the Municipal Treasurer, DSWD Regional Office- IV-A, and other concerned offices, for their information and appropriate action
