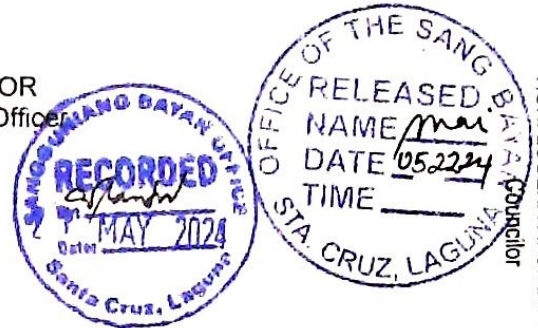

RESOLUTION NO. 237-S2024

A RESOLUTION AUTHORIZING THE HON. MAYOR EDGAR S. SAN LUIS ON BEHALF OF THE MUNICIPAL GOVERNMENT OF SANTA CRUZ TO SIGN A MEMORANDUM OF AGREEMENT WITH SOCIAL SECURITY SYSTEM FOR THE ASSISTANCE GIVEN BY THE MUNICIPAL GOVERNMENT OF SANTA CRUZ, LAGUNA ON ITS REGULAR / PERMANENT EMPLOYEES AND COS/JO PERSONNEL WHO ARE MEMBERS OR UNDER THE SCOPE OF SOCIAL SECURITY SYSTEM TO AUTOMATICALLY DEDUCT AND REMIT TO THE NEAREST SSS BRANCH THEIR MONTHLY CONTRIBUTIONS FROM THEIR SALARIES, WAGES AND / OR FEES WHO OPT TO CONTINUE PAYING AS VOLUNTARY MEMBERS BASED ON THEIR PREFERRED MONTHLY CONTRIBUTION.

WHEREAS, through an endorsement from the Hon. Mayor Edgar S. San Luis this august body favorably considered and referred the request to the committee for discussion and deliberation;

WHEREAS, the Municipal Government of Santa Cruz encourages and assists its Contract of Service (COS) and Job Order (JO) Personnel not covered under the Government Service Insurance System (GSIS) Law to have protection against hazards of disability, sickness, maturity, old age, death, and other contingencies that the Social Security System (SSS) offers;

WHEREAS, regular / permanent employees of the Municipal Government of Santa Cruz who are existing SSS members may also opt to continue paying contributions as voluntary members;

WHEREAS, the undertakings of both parties are stipulated in the Memorandum of Agreement;

WHEREAS, realizing the benefits that the regular / permanent employees and COS/ JO personnel can avail from their contributions to the Social Security System, it was recommended for approval of the body;

WHEREFORE, on motion of Hon. Esmeraldo C. De Las Armas, Jr. (Chairman of the Committee on Good Governance, Public Ethics and Public Accountability); duly seconded by all the members of the Sangguniang Bayan present, it was

RESOLVED To authorize the Hon. Mayor Edgar S. San Luis on Behalf of the Municipal Government of Santa Cruz to Sign A Memorandum of Agreement with Social Security System (SSS) for the Assistance given by the Municipal Government of Santa Cruz, Laguna on its Regular / Permanent Employees and COS/JO Personnel who are members or under the Scope of Social Security System to Automatically Deduct and Remit to the nearest SSS Branch their Monthly Contributions from their Salaries, Wages and / or Fees who Opt to Continue Paying as Voluntary Members Based on their Preferred Monthly Contribution.

ORDERED: Let copies of this resolution be furnished the Hon. Mayor Edgar S. San Luis, the Municipal Treasurer, the Municipal Budget Officer, the Municipal Accountant, the Municipal Planning and Development Officer, the Human Resource Management Officer, the Social Security System - Santa Cruz Branch and all other concerned offices, this municipality, for their information and appropriate action.


