A RESOLUTION APPROVING THE SUPPLEMENTAL BUDGET FOR THE RELEASE OF SERVICE RECOGNITION INCENTIVE (SRI) FOR FY 2023 FOR ELECTED OFFICIALS, PERMANENT AND CASUAL EMPLOYEES AMOUNTING TO SEVEN MILLION FOUR THOUSAND PESOS (Php7,004,000.00) FROM THE SAVINGS OF FUNDED VACANT POSITIONS OF DIFFERENT OFFICES TO OTHER PERSONAL BENEFITS, AND FOR THE GRATUITY PAY TO JOB ORDER WORKERS FOR FY 2023 AMOUNTING TO Php1,805,000.00 FROM THE SAVINGS OF THE MAINTENANCE AND OTHER OPERATING EXPENDITURES TO OTHER MAINTENANCE AND OPERATING EXPENSES OF THE OFFICE OF THE MAYOR, MUNICIPALITY OF SANTA CRUZ, LAGUNA, SUBJECT TO EXISTING LEGAL LAWS, RULES AND REGULATIONS.

WHEREAS, Local Budget Circular No. 2023- 2 dated December 13, 2023 – provides Guidelines on the grant of Service Recognition Incentive (SRI) to all Government Employees for FY 2023 in the amount of Twenty Thousand Pesos (Php20,000.00);

WHEREAS, Local Budget Circular No. 2023- 3 dated December 14, 2023 – provides Guidelines on the the grant of Gratuity Pay to Job Order Workers in Government for FY 2023 in the amount of Five Thousand Pesos (Php5,000 00) depending on the length of service;

WHEREAS, the government continues to acknowledge all Public Servants for their collective and unceasing participation in and invaluable contribution to the establishment of streamlined government processes and responsive delivery of services to the public;

WHEREAS, the grant of Service Recognition Incentive (SRI) and Gratuity Pay to Government Employees for FY 2023 is in recognition of their hard work, commitment and dedication to Public Service;

WHEREAS, an endorsement from Honorable Municipal Mayor Edgar S. 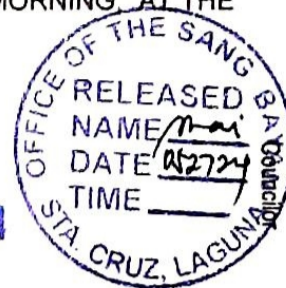
