**RESOLUTION NO. 249-S2024** 

A RESOLUTION AUTHORIZING THE HON. MAYOR EDGAR S. SAN LUIS ON BEHALF OF THE MUNICIPAL GOVERNMENT OF SANTA CRUZ TO SIGN A TRIPARTITE AGREEMENT WITH SANTA CRUZ WATER DISTRICT (SCWD), PRIME WATER AND BUREAU OF FIRE PROTECTION, SANTA CRUZ, LAGUNA IN LINE WITH SCWD AND PRIME WATER COMPLIANCE TO LWUA-MC NO. 005-23; REDUCTION OF THE LEVEL OF NON REVENUE WATER AS WATER CONSERVATION MEASURE AND CONDUCTING OF FIRETRUCK REFILLING FOR FLUSHING ACTIVITIES AND THE LIKE WITHIN THE MUNICIPALITY OF SANTA CRUZ, LAGUNA.

WHEREAS, presented to the Sangguniang Bayan is an endorsement regarding the abovementioned subject;

WHEREAS, with its referral and in the deliberation of the committees, the rights and obligations of the parties were identified and taken into consideration, along with the other conditions required in it, thus the committees recommend for its approval;

San Luis on behalf of the Municipal Government of Santa Cruz to sign a Tripartite Agreement with Santa Cruz Water District, Prime Water and Bureau of Fire Protection, Santa Cruz, Laguna in line with SCWD and Prime Water Compliance to LWUA-MC No. 005-23; Reduction of the Level of Non Revenue Water as Water Conservation Measure and Conducting of Firetruck Refilling for Flushing Activities and the like within the Municipality of Santa Cruz, Laguna.
