A RESOLUTION ACKNOWLEDGING / APPROVING THE MOTION TO WITHDRAW THE INITIAL COMPLAINT OF HON. COUNCILOR JERALD A. REYES AGAINST BARANGAY CHAIRMAN PERCY A. SAN MIGUEL, BOTH OF BARANGAY PATIMBAO, SANTA CRUZ, LAGUNA.

WHEREAS, filed before the Sangguniang Bayan on April 03, 2024 was a Complaint Affidavit of Hon. Barangay Councilor Jerald A. Reyes against Barangay Chairman Percy A. San Miguel;

WHEREAS, upon its referral to the Quasi-Judicial Body, Hon. Percy A. San Miguel was notified and instructed to submit his Counter-Affidavit 15 days upon receipt of the notice and the copy of the complaint-affidavit;

WHEREAS, on April 23, 2024, Hon. Jerald A. Reyes filed his Motion to Withdraw his complaint last April 03, 2024 for the reason that the complaint was mistakenly filed by his representative, which was intended to be filed in the Regional Trial Court (RTC) for Criminal Case of Malversation, and exchange it with verified administrative complaint for Grave Abuse of Authority/ Grave Abuse of Discretion;

WHEREAS, on April 25, 2024 Hon. Percy A. San Miguel submitted his Counter- Affidavit to the Complaint of Hon. Coun. Jerald A. Reyes,

WHEREAS, in consideration of the Motion to Withdraw, the Quasi Judicial Body invited/ ordered Hon. Councilor Jerald A. Reyes for clarification of his withdrawal of the case;

WHEREAS, upon the advice of Atty. Ronaldo C. Mariano, Municipal Legal Officer, since the Quasi-Judicial Body has no Internal Rules regarding the withdrawal of the case, the guidance of the Rules of Court prevails, wherein the complainant can file his Motion to Withdraw if the respondent has not submitted / filed his counter affidavit yet however, if the respondent has submitted his Counter Affidavit before the Motion to Withdraw, it is the discretion of the Quasi-Judicial Body whether to accept the withdrawal or not.

WHEREFORE: on motion of Hon. Laura P. Obligacion (Chairman of Quasi Judicial Body), duly seconded by Hon Rizaldy N. Kalaw, Hon Ambiel John C. Panganiban, Hon. Esmeraldo C. De Las Armas, Jr. and Hon. Lucena R. Odejar and with the approval of the members of the Sangguniang Bayan, it was

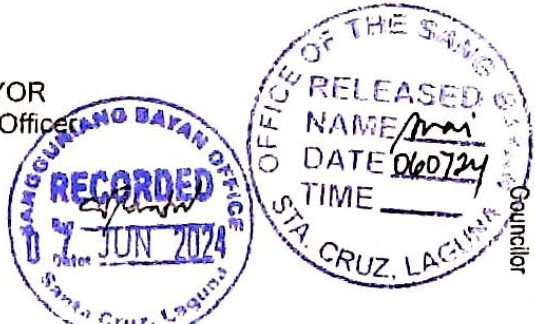


