RESOLUTION NO. 263-S2024

A RESOLUTION AUTHORIZING THE HON. MAYOR EDGAR S. SAN LUIS TO AVAIL OF THE BENEFITS OF PRESIDENT FERDINAND MARCOS, JR.'s PAMBANSANG PABAHAY PARA SA PILIPINO (4PH) WITH SPECIFIC AUTHORITY TO ENTER INTO AGREEMENTS WITH DEPARTMENT OF HUMAN SETTLEMENTS AND URBAN DEVELOPMENT (DHSUD), PAG-IBIG, AND QUALIFIED DEVELOPERS/ CONTRACTORS TO WIDEN THE 4PH PROGRAM.

WHEREAS, endorsed to the august body is a request to pass a resolution relative to the aforementioned subject;

WHEREAS, the Pambansang Pabahay para sa Pilipino Program is the flagship housing program of President Ferdinand Marcos, Jr. which aims to develop housing units to bridge the country's 6.5 million housing gap;

WHEREAS, all Filipinos, especially those coming from the urban poor, informal settler families, informal sectors, minimum wage earners, Government Employees, Overseas Filipino Workers (OFW), TNUS, and PUV drivers / Operators can avail of the 4PH Program;

WHEREAS, a resolution is important to allow the Local Chief Executive to enter into a Memorandum of Agreement with the implementing agencies of the Pambansang Pabahay Para sa Pilipino (4PH) program to provide interest support to reduce beneficiaries monthly amortization;

WHEREAS, with the considerations enumerated, the committee recommends for the approval of the resolution needed.

WHEREFORE, upon motion of Hon. Lucena R. Odejar (Chairman of Committee on Housing and Land Use), duly seconded by Hon. Ambiel John C. Panganiban, Kgg. Norman T. Tolentino at Kgg. Alan T. Pamatmat and with the approval of the members of the Sangguniang Bayan, it was

RESOLVED: To Authorize the Hon. Mayor Edgar S. San Luis to avail of the benefits of President Ferdinand Marcos, Jr.'s Pambansang Pabahay Para sa Pilipino (4PH) with specific authority to enter into agreements with Department of Human Settlements and Urban Development (DHSUD), Pag-Ibig, and Qualified Developers/ Contractors to Widen the 4PH Program.
