ORDINANCE NO. 011- S2024

AN ORDINANCE EXTENDING THE VALIDITY OF THE COMPREHENSIVE LAND USE PLAN (CLUP) 2013 - 2023 AND COMPREHENSIVE DEVELOPMENT PLAN (CDP) 2013 - 2023 OF THE MUNICIPALITY OF SANTA CRUZ, LAGUNA UNTIL DECEMBER 31, 2024.

WHEREAS, the Hon. Mayor Edgar S. San Luis sent a request to the Hon. Sangguniang Bayan to pass a resolution or ordinance pertaining to the CLUP and CDP of this municipality;

WHEREAS, the DILG's assessment for eligibility to receive the 2024 Seal of Good Local Governance (SGLG) requires that a Local Government Unit must pass in all governance areas which includes an approved CLUP and CDP;

WHEREAS, the effectivity dates of the CLUP 2013-2023 approved through Sangguniang Panlalawigan Resolution No. 309-S2018 on June 20, 2018 and the CDP - 2013 - 2023 lapsed on December 31, 2023, which is why both these plans are currently in the updating stage.

NOW THEREFORE, on motion of Hon. Lucena R. Odejar (Chairman of Committee on Housing and Land Use), duly seconded by Hon. Alan T. Pamat and with the approval of the members of the Sangguniang Bayan, it was

Be it Ordained by the Sangguniang Bayan of Santa Cruz, Laguna in its Regular Session Assembled:

SECTION 1 - To extend the validity of the Comprehensive Land Use Plan (CLUP) 2013 - 2023 and Comprehensive Development Plan (CDP) 2013 - 2023 of the Municipality of Santa Cruz, Laguna until December 31, 2024.

SECTION 2 - This Ordinance shall take effect upon its approval.

ORDERED: Let copies of this ordinance be furnished the Honorable Mayor, the Municipal Budget Officer, the Municipal Accountant, the Municipal Treasurer, the Municipal Planning and Development Coordinator, the Municipal Assessor, the Municipal Disaster Risk and Reduction Officer, the Department of Interior and Local Government and all other concerned offices, all this municipality, for their information and appropriate action.


