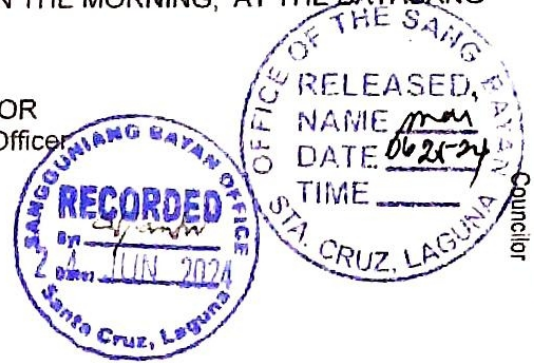

A RESOLUTION AUTHORIZING THE HON. MAYOR EDGAR S. SAN LUIS IN BEHALF OF THE MUNICIPALITY OF SANTA CRUZ, LAGUNA TO SIGN A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT (DSWD) FIELD OFFICE (FO) IV-CALABARZON, FOR THE SUSTAINABLE LIVELIHOOD PROGRAM TO DELIVER A PACKAGE OF SERVICES TO ADDRESS POVERTY, EMPOWER CITIZENS AND PROMOTE INCLUSIVE GROWTH.
