WHEREAS, presented before the august body is the above mentioned request;

WHEREAS, pursuant to GSIS Memorandum Circular No. 055, S2024 – Utilization of Electronic Collection for Agency Remittances, the use of electronic data messages, electronic documents and technology in performing government functions such as but not limited to, collection and payment is allowed,

WHEREAS, the use of an Electronic Collection (e-Collection) or Electronic Payment (e-Payment) system is encouraged, pursuant to the Electronic Commerce Act of 2020; and Ease of Doing Business and Efficient Government Service Delivery Act of 2018;

NOW THEREFORE, on motion of Hon. Esmeraldo C. De Las Armas, Jr. (Chairman of the Committee on Good Governance, Public Ethics and Public Accountability), duly seconded by all members of the Sangguniang Bayan, it was.

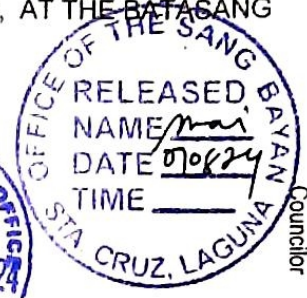
