**WHEREAS**, attached to the endorsement of the Municipal Administrator as authorized by the Honorable Mayor, is a request-letter from the Municipal Health Officer for consideration and support on the passing of a municipal ordinance to strengthen the immunization program of the municipality;

**WHEREAS**, the Municipal Health Office has started a project on creating a policy to strengthen said program, while the Department of Health has released a Memorandum on Accelerating the National Immunization program which include involvement of non-government organizations and the private sector, working together to achieve a 95% fully immunized child coverage, and to achieve targets on good governance on health;

**WHEREAS**, this resolution of support to a future ordinance signifies the Local Government Unit's endorsement for the project and demonstrates its collective commitment to providing quality healthcare aligned to the Universal Health Care Law.

**NOW THEREFORE**, on motion of Hon. Esmeraldo C. De Las Armas, Jr. (Chairman of the Committee on Health, Sanitation and Nutrition), duly seconded by all the members of the Sangguniang Bayan present, it was
