RESOLUTION NO. 295-S2024

A RESOLUTION AUTHORIZING THE HON. MAYOR EDGAR S. SAN LUIS ON BEHALF OF THE MUNICIPAL GOVERNMENT OF SANTA CRUZ, LAGUNA TO SIGN THE MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT FIELD OFFICE IV-A (DSWD FO IV-A) REPRESENTED BY ITS REGIONAL DIRECTOR DR. BARRY R. CHUA, MD, FOR THE IMPLEMENTATION OF THE REVISED GUIDELINES PARTICULARLY "MEMORANDUM CIRCULAR 06-SERIES OF 2024 OR THE ENHANCED OMNIBUS GUIDELINES IN THE IMPLEMENTATION OF THE SOCIAL PENSION FOR INDIGENT SENIOR CITIZENS".

WHEREAS, for consideration of the Honorable Sangguniang Bayan is the above-mentioned endorsement from the Hon. Mayor Edgar S. San Luis ;

WHEREAS, the Sangguniang Bayan previously passed Resolution No. 236- S2024 Granting the Hon. Mayor Edgar S. San Luis on behalf of the municipality to enter into a Memorandum of Agreement with the DSWD FO IV-A for the transfer of fund for the stipend of social pensioners to expedite the semestral distribution of said stipend ;

WHEREAS, to continuously improve the program implementation, a revised guidelines were issued through "Memorandum Circular 06- Series of 2024" or the Enhanced Omnibus Guidelines in the Implementation of the Social Pension for Indigent Senior Citizens, which highlights the frequency of distribution from semestral to quarterly basis, aiming to distribute the stipend to a more timely manner;

WHEREAS, the Local Government Unit of Santa Cruz's commitment in implementing the Social Pension Program for Indigent Senior Citizens through Fund Transfer Scheme contributed in the efficient distribution of stipend to the Senior Citizens in the past semester;

NOW THEREFORE, on motion of Hon. Lea A. Almarvez (Chairman of the Committee on Social Welfare and Development, Family and Women), duly seconded by Hon. Esmeraldo C. De Las Armas, Jr. and Hon. Ambiel John C. Panganiban, Hon. Norman T. Tolentino, Hon. Rizaldy N. Kalaw, Hon. Lucena R. Odejar, Hon. Mark Anthony M. Juangco and Hon. Laura P. Obligacion and with approval of the members of the Sangguniang Bayan present, it was

RESOLVED: To authorize the Hon. Mayor Edgar S. San Luis on behalf of the Municipal Government of Santa Cruz, Laguna to sign the Memorandum of Agreement with the Department of Social Welfare and Development Field Office IV-A (DSWD FO IV-A) represented by its Regional Director Dr. Barry R.
