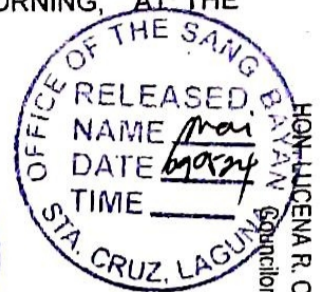

RESOLUTION NO. 298-S2024

A RESOLUTION AUTHORIZING THE HON. MAYOR EDGAR S. SAN LUIS ON BEHALF OF THE MUNICIPAL GOVERNMENT OF SANTA CRUZ, LAGUNA TO SIGN THE MEMORANDUM OF UNDERSTANDING WITH SOLID CEMENT CORPORATION FOR THE COLLECTION AND DISPOSAL OF CONSOLIDATED RESIDUAL PLASTIC WASTES.

WHEREAS, endorsed to the Sangguniang Bayan is the above-mentioned subject matter;

WHEREAS, in the committee's deliberation and discussion with the Acting Municipal General Services Officer, the terms and conditions stipulated in the Memorandum of Understanding which includes the obligation of both the Municipal Government of Santa Cruz, Laguna and Solid Cement Corporation, the contract price, term and renewal, and mutual warrants, were taken up, in compliance with Republic Act 9003 otherwise known as the "Ecological Solid Waste Management Act of 2020".

Panganiban, Kgg. Esmeraldo C. De Las Armas, Jr. and Hon. Laura P. Obligacion and with approval of the members of the Sangguniang Bayan present, it was

RESOLVED: To authorize the Hon. Mayor Edgar S. San Luis on behalf of the Municipal Government of Santa Cruz, Laguna to sign the Memorandum of Understanding with Solid Cement Corporation for the Collection and Disposal of Consolidated Residual Plastic Wastes
