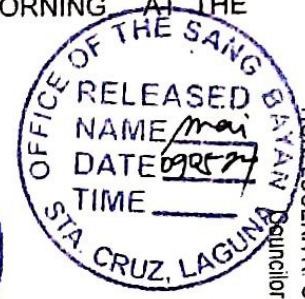

**RESOLUTION NO. 301-S2024**

**A RESOLUTION AUTHORIZING THE HON. MAYOR EDGAR S. SAN LUIS ON BEHALF OF THE MUNICIPAL GOVERNMENT OF SANTA CRUZ, LAGUNA TO SIGN THE MEMORANDUM OF AGREEMENT WITH THE PROVINCE OF LAGUNA REPRESENTED BY THE PROVINCIAL GOVERNOR HON. RAMIL L. HERNANDEZ FOR THE FUND ASSISTANCE TO BE UTILIZED EXCLUSIVELY FOR THE PROJECT "COMMUNITY DEVELOPMENT PROGRAM".**

**WHEREAS**, endorsed to the Sangguniang Bayan is the above-mentioned subject matter;

**WHEREAS**, the Municipality of Santa Cruz, Laguna has been identified by the Province of Laguna as an active partner in the delivery of key services to the constituents of the province, thus, the Municipality of Santa Cruz proposed the implementation of a Community Development Program;

**WHEREAS**, the Provincial Government of Laguna recognizes and supports the proposed project of the Municipality of Santa Cruz and its capacity to actively participate in the implementing of national programs and projects;

**WHEREAS**, the Memorandum of Agreement will cover fund assistance to be utilized exclusively for the project "Community Development Program" for the second quarter to the fourth quarter of Calendar Year 2023 in the total amount of Seven Hundred Fifty Thousand Pesos (P750,000.00) to be utilized not later than December 31, 2024;

**WHEREAS**, after the committee's deliberation and discussion with the Municipal Administrator and the Municipal Accountant, the committee recommends for the approval of the request,

**NOW THEREFORE**, on motion of Hon. Rizaldy N. Kalaw (Chairman of Committee on Budget and Appropriations), duly seconded by Hon. Ambiel John C. Panganiban, Hon. Lea A. Almarvez, Hon. Norman T. Tolentino, Hon. Esmeraldo C. De Las Armas, Jr., Hon. Mark Anthony M. Juangco and Hon. Lucena R. Odejar and with approval of the members of the Sangguniang Bayan present, it was

San Luis on behalf of the Municipal Government of Santa Cruz, Laguna to sign the Memorandum of Agreement with the Province of Laguna Represented by the Provincial Governor Hon. Ramil L.
