MARCOS, JR., PRESIDENT OF THE REPUBLIC OF THE PHILIPPINES, THROUGH THE LOCAL GOVERNMENT SUPPORT FUND, FINANCIAL ASSISTANCE TO LOCAL GOVERNMENT UNITS (LGSF-FA TO LGUS) UNDER THE DEPARTMENT OF BUDGET AND MANAGEMENT, FOR THE CONSTRUCTION OF MUNICIPAL HALL EXTENSION BUILDING IN THE AMOUNT OF P300,000,000.00.**

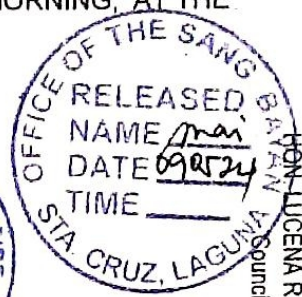
