RESOLUTION NO. 035-S2024

A RESOLUTION AUTHORIZING THE HON. MAYOR EDGAR S. SAN LUIS TO SIGN FOR AND IN BEHALF OF THE MUNICIPAL GOVERNMENT OF SANTA CRUZ, LAGUNA THE MEMORANDUM OF AGREEMENT WITH THE UNIVERSITY OF THE PHILIPPINES, LOS BAÑOS FOR THE MUNICIPALITY TO BE INCLUDED IN THE TECHNICAL ASSISTANCE PROGRAM ON HUMAN SETTLEMENT PLANNING (TAP-HSP) OF THE DEPARTMENT OF COMMUNITY AND ENVIRONMENT RESOURCE PLANNING OF THE UPLB COLLEGE OF HUMAN ECOLOGY (DECERP-CHE).

WHEREAS, the Hon. Mayor Edgar S. San Luis had an endorsement to this august body pertaining to the above subject matter.

WHEREAS, the Memorandum of Agreement stipulates that the Local Government of Santa Cruz and UPLB have Mutual concerns and pledge their cooperation and support for the operationalization of TAP-HSP regarding the formulation of the Climate and Disaster Risk Assessment (CDRA) and the Comprehensive Land Use Plan (CLUP) for the Municipality of Santa Cruz,

WHEREAS, after a thorough discussion and evaluation, the same is recommended by the committee to authorize the Honorable Mayor to enter into a Memorandum of Agreement.
