RESOLUTION NO. 306-S2024

A RESOLUTION GRANTING AN AUTHORITY TO THE HON. MAYOR EDGAR S. SAN LUIS TO SIGN A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT FIELD OFFICE IV-A, REPRESENTED BY ITS REGIONAL DIRECTOR DR. BARRY R. CHUA, M.D. FOR THE PROVISION ON TECHNICAL AND RELIEF SERVICES, AND AUGMENTATION ASSISTANCE FOR THE VICTIMS DURING AND IN THE AFTERMATH OF DISASTERS.

WHEREAS, there is an endorsement from the Hon. Mayor Edgar S. San Luis regarding said request.

WHEREAS, the Local Government Unit under RA 7160 otherwise known as the "Local Government Code" provides that the Local Government Units shall provide relief services for the victims during and in the aftermath of disasters and their return to productive livelihood following the said event;

WHEREAS, the Memorandum of Agreement (MOA) will cover the preposition of emergency Food and Non-Food Relief items to the Municipal Government of Santa Cruz, Laguna from the Department of Social Welfare and Development.
