RESOLUTION TEMPORARILY ALLOWING STALLS OF FLOWERS AND CANDLE VENDORS TO OCCUPY THE STREETS ALONG A. REGIDOR STREET, OPPOSITE ROAD FROM SOUTH EMERALD TO SANTISIMA CRUZ ELEMENTARY SCHOOL LOCATED ALONG THE MUNICIPAL PUBLIC MARKET OF THE MUNICIPALITY OF SANTA CRUZ, LAGUNA FROM OCTOBER 29 TO NOVEMBER 1, 2024.

WHEREAS, Sangguniang Bayan is of a receipt of a request letter from Honorable Mayor Edgar S San Luis dated October 28, 2024 seeking assistance to allow stalls of flowers and candle vendors to occupy the streets along Regidor Street, and opposite road from South Emerald to Santisima Cruz Elementary School on October 29 to November 1, 2024;

WHEREAS, the request was referred to the Committee on Market and Slaughterhouse for evaluation;

WHEREAS, after thorough evaluation and deliberation it was recommended for its approval.

NOW THEREFORE, on motion of Hon. Mark Anthony M. Juangco (Vice Chairman of the Committee on Market and Slaughterhouse), duly seconded by all the members of the Sangguniang Bayan present, it was

RESOLVED as it is hereby **RESOLVED**: Temporarily allow stalls of flowers and candle vendors to occupy the streets along A. Regidor Street, opposite road from South Emerald to Santisima Cruz Elementary School located along the Municipal Public Market of the Municipality of Santa Cruz, Laguna from October 29 to November 1, 2024.
