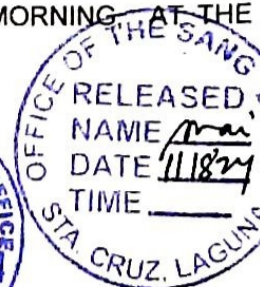

RESOLUTION NO. 358-S2024

A RESOLUTION AUTHORIZING THE HONORABLE MAYOR EDGAR S. SAN LUIS AND THE ACTING MUNICIPAL TREASURER MARLENE AÑONUEVO IN BEHALF OF THE MUNICIPAL GOVERNMENT OF SANTA CRUZ, LAGUNA TO SIGN AND/OR EXECUTE ALL DOCUMENTS NECESSARY AND RELEVANT TO THE EXERCISE OF AUTHORITY OVER THE MUNICIPAL ACCOUNT IN THE DEVELOPMENT BANK OF THE PHILIPPINES (DBP).

WHEREAS, the Hon. Mayor Edgar S. San Luis endorsed to the august body the above-mentioned request and referred to the Committee on Finance, Budget and Appropriation and Committee on Laws and Ordinances, for discussion;

WHEREAS, a municipal account is registered under the DPB where the signatories for official transactions are the Honorable Mayor Edgar S. San Luis and Municipal Treasurer Ronaldo O. Valles;

WHEREAS, by reason for recent events which required immediate medical attention to our Municipal Treasurer Ronaldo O. Valles, and consequently the appointment Marlene R. Añonuevo, as the Acting Municipal Treasurer, a new Memorandum of Agreement with the Development Bank of the Philippines is necessary to sign and /or execute all documents necessary and relevant to the exercise of authority over the Municipal Account in the Development Bank of the Philippines (DBP).

WHEREAS, upon deliberation, the committees find it necessary to consider the request, thus its approval.

NOW THEREFORE, on motion of Hon. Rizaldy N. Kalaw (Chairman of the Committee on Finance, Budget and Appropriation), duly seconded by Hon. Norman T. Tolentino, Hon. Ambiel John C. Panganiban and Hon. Lucena R. Odejar and with the approval of the members of the Sangguniang Bayan, it was
