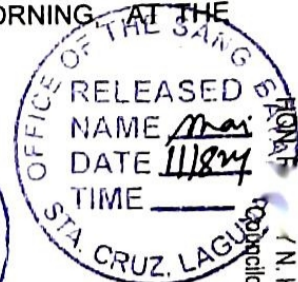

RESOLUTION NO. 359-S2024

A RESOLUTION AUTHORIZING THE HONORABLE MAYOR EDGAR S. SAN LUIS IN BEHALF OF THE MUNICIPAL GOVERNMENT OF SANTA CRUZ, LAGUNA TO SIGN A MEMORANDUM OF AGREEMENT WITH THE DEVELOPMENT BANK OF THE PHILIPPINES (DBP) REPRESENTED BY JOEL G. JALBUENA FOR THE SALARY LOAN FACILITY.

WHEREAS, the Hon. Mayor Edgar S. San Luis endorsed said request to the august body and referred to the Committee on Finance, Budget and Appropriation and Committee on Laws and Ordinances, for discussion;

WHEREAS, a Memorandum of Agreement between the Municipality of Santa Cruz represented by Hon. Edgar S. San Luis and the Development Bank of the Philippines represented by Joel G. Jalbuena was previously signed;

WHEREAS, by reason for recent events which required immediate medical attention to the Municipal Treasurer Ronaldo O. Valles, and consequently the appointment Marlene R. Añonuevo, as the Acting Municipal Treasurer, a new Memorandum of Agreement with the Development Bank of the Philippines is necessary to carry out the obligations in the previously signed MOA,

WHEREAS, upon deliberation, the committees find it necessary to consider the request, thus its approval.

NOW THEREFORE, on motion of Hon. Rizaldy N. Kalaw (Chairman of the Committee on Finance, Budget and Appropriation), duly seconded by Hon. Lucena R. Odejar, Hon. Norman T. Tolentino and Hon. Ambiel John C. Panganiban and with the approval of the members of the Sangguniang Bayan, it was

RESOLVED: To authorize the Honorable Mayor Edgar S. San Luis in behalf of the Municipal Government of Santa Cruz, Laguna to sign a Memorandum of Agreement with the Development Bank of the Philippines (DBP) represented by Joel G. Jalbuena for the Salary Loan Facility.

San Luis, the Municipal Treasurer, the Municipal Budget Officer, the Municipal Accountant, the Municipal Planning and Development Officer, the Development Bank of the Philippines, and all other concerned offices, for their information and appropriate action.
