**A RESOLUTION AUTHORIZING THE HON. MAYOR EDGAR S. SAN LUIS IN BEHALF OF THE MUNICIPALITY OF SANTA CRUZ, LAGUNA TO SIGN A MEMORANDUM OF AGREEMENT WITH THE CITY SAVINGS BANK, INC. REPRESENTED BY ITS REGIONAL BUSINESS HEAD FOR IV-A, MARISSA T. TOGADO FOR THE "MULTI-PURPOSE LOAN FACILITY" EXTENDED TO THE ELIGIBLE EMPLOYEES .**
