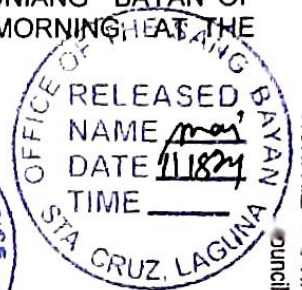

RESOLUTION NO. 361-S2024

A RESOLUTION AUTHORIZING THE HON. MAYOR EDGAR S. SAN LUIS IN BEHALF OF THE MUNICIPALITY OF SANTA CRUZ, LAGUNA TO SIGN A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT (DSWD) REPRESENTED BY ITS SECRETARY HON. REXLON T. GATCHALIAN, FOR THE TECHNICAL ASSISTANCE (TA) AND RESOURCES AUGMENTATION (RA).

WHEREAS, the Hon. Mayor Edgar S. San Luis endorsed said request to the august body and referred to the Committee on Social Welfare and Development for discussion;

WHEREAS, Technical Assistance (TA) consists of non monetary interventions which are designed to enhance the capability of LSWDOS based on needs and assessment, for the effective implementation of social welfare and development programs, projects and services;

WHEREAS, Resource Augmentation (RA) is the provision for support to LGUs / LSWDOs for the immediate response and early recovery of victims of disaster and implementation of other LSWDO- led programs and projects as mandated by existing laws and as maybe provided for by existing DSWD policies and programs.
