RESOLUTION NO. 438-S2024

A RESOLUTION AUTHORIZING THE HONORABLE MAYOR EDGAR S. SAN LUIS TO SIGN A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT (DSWD) THROUGH ITS REGIONAL OFFICE IV-A FOR THE IMPLEMENTATION OF CRISIS INTERVENTION THROUGH THE ASSISTANCE TO INDIVIDUALS AND FAMILIES IN CRISIS - SITUATION (AICS) PROGRAM.

WHEREAS, received by the august body an endorsement referring to the above subject matter;

WHEREAS, Executive Order (EO) No. 221 series of 2003 and Executive Order No. 137- series of 2021 were passed to implement the Assistance to Individuals and Families in Crisis Situation (AICS) program;

WHEREAS, the Department of Social Welfare and Development issued Memorandum Circular (MC) No. 16-series of 2022 which provides for the different modes of disbursement strategies;

WHEREAS, the Local Government Units are mandated by law to discharge basic services, including social welfare services to its constituents;

WHEREAS, upon its deliberation, the committee ascertains the usefulness of the said program in providing assistance to individuals and families in crisis - situation.

NOW THEREFORE, on motion of Hon. Lea A. Almarvez (Chairman of Committee on Social Welfare and Development, Family and Women), duly seconded by Hon. Ambiel John C. Panganiban, Hon. Mark Anthony M. Juangco, Hon. Lucena R. Odejar and Hon. Norman T. Tolentino and with the approval of the members of the Sangguniang Bayan present, it was

RESOLVED: To authorize the Honorable Mayor Edgar S. San Luis to sign a Memorandum Of Agreement with the Department of Social Welfare and Development (DSWD) through its Regional Office IV-A for the implementation of crisis intervention through the Assistance To Individuals And Families In Crisis - Situation (AICS) program.

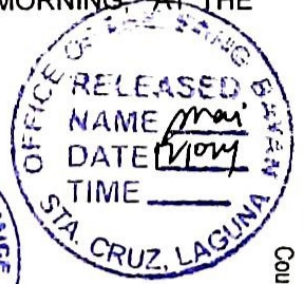
