RESOLUTION NO. 504-S2024

A RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR EDGAR S. SAN LUIS TO SIGN THE USUFRUCT AGREEMENT BETWEEN THE MUNICIPAL GOVERNMENT OF SANTA CRUZ, LAGUNA IN FAVOR OF THE PHILIPPINE NATIONAL POLICE STATION REPRESENTED BY ITS CHIEF OF POLICE PLTCOL MARK JULIUS REBANAL.

WHEREAS, endorsed to the august body is the above-request from the Local Chief Executive;

WHEREAS, the endorsement upon its referral to the committee the endorsement was reviewed and considered in light of the effective enforcement of the Mandate of the Philippine National Police particularly the Santa Cruz Municipal Police Station, in maintaining peace and order, ensuring they are equipped with necessary resources to perform their functions;

WHEREAS, the Municipal Government of Santa Cruz, Laguna owns four motor vehicles and given the right to the Municipal Police Station (MPS) to the use and enjoyment of these vehicles for the benefits of the constituents of Santa Cruz;

WHEREAS, the committee favors the agreement containing the terms and conditions to be adhered to by both parties;

RESOLVED: To authorize the Municipal Mayor Edgar S. San Luis to sign the Usufruct Agreement between the Municipal Government of Santa Cruz, Laguna in favor of the Philippine National Police Station represented by its Chief of Police PLTCOL Mark Julius Rebanal.
