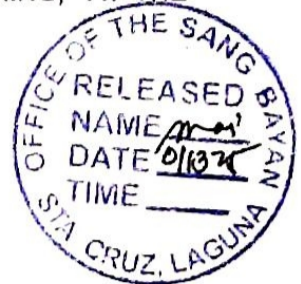

**A RESOLUTION AUTHORIZING THE HONORABLE MAYOR EDGAR S. SAN LUIS TO IMPLEMENT THE PROVISIONS STATED IN THE ISSUED PHILHEALTH CIRCULARS REGARDING THE IMPLEMENTING GUIDELINES FOR THE MUNICIPAL HEALTH CARE PRIMARY CARE BENEFIT (PCB) ON THE ALLOCATION OF PROCEEDS FROM PHILHEALTH MEDICAL SERVICES.**

**WHEREAS**, endorsed to the august body is the above request for consideration;

**WHEREAS**, for the betterment and improvement of the services provided by the Municipal Health Office, it is essential for the Municipal Health Office to utilize and receive the Universal Health Care Primary Benefit;

**WHEREAS**, each program of Philhealth has its own allocation;


