RESOLUTION NO. 082- S2025

RESOLUTION AUTHORIZING THE MUNICIPAL HEALTH OFFICE TO OPERATE A PRIMARY CARE FACILITY IN THE MUNICIPALITY TO BE KNOWN AS SANTA CRUZ PRIMARY CARE FACILITY.

WHEREAS, Republic Act No. 11223 otherwise known as the Universal Health Care Act mandates that every Filipino shall have immediate access to preventive, promotive, curative, rehabilitative, and palliative care for medical, dental, mental and emergency health services, through a primary care provider and primary care facilities which underwent the Department of Health Licensing and Regulatory System for stand-alone health facilities, including those providing ambulatory and primary care services;

WHEREAS, the Department of Health issued Administrative Order 2020-047 "Rules and Regulations Governing the Licensure of Primary Care Facilities in the Philippines", promulgating licensing standards and requirements for primary care facilities (PCFs), including rural health units and barangay health stations, ensuring and capacitating PCFS to deliver initial-contact, accessible, continuous, comprehensive and coordinated care to the communities they serve;

WHEREAS, in January 2023, the municipality has signed into a Memorandum of Agreement with the Provincial Government of Laguna on the province-wide health system integration together with other local government units in the province, aiming to ensure the coordinated and collective efforts of its components towards better health outcomes, health system responsiveness and financial risk protection, agreeing to take shared responsibility on how collective resources are organized, managed, delivered, and financed;

WHEREAS, corollary to the province-wide health system integration, the Province has undertaken significant steps in the formation of the Primary Care Provider Network (PCPN) which has been contracted with the Philhealth Konsulta Package sandbox implementation, and the reorganization and renaming of the provincial hospital system into the Laguna Provincial Hospital Network and parallel to these efforts the Provincial Health Office so advised similar undertaking to standardize health facility nomenclature among primary care facilities;

WHEREAS, consistent with the thrust of the municipal government to provide and deliver quality health services to the constituents in line with implementation of Universal Health Care, the Municipal Health Office is working or undertaking measures to secure a license to operate a primary care facility, and in accordance with the standards, criteria and requirements set by the DOH shall endeavor to offer the following health services;

- a. Medical Consultation
- b. Minor Surgery
- c. Birthing Service
- d. Ambulance and/or patient transport services
- e. Dental services
- f. Clinical Laboratory
- g. Pharmacy
- h. Basic radiology and imaging
- i. Delivery of TB Services (DOTS)
- j. Animal Bite Treatment Center
- k. Epidemiology and surveillance
- Disaster risk reduction and management in health, among others,
