RESOLUTION CONCURRING THE APPOINTMENT OF MR. ROGELIO A. CRUZ, JR. AS MUNICIPAL BUDGET OFFICER OF THE MUNICIPAL GOVERNMENT OF SANTA CRUZ, LAGUNA PURSUANT TO SECTION 454 (d) OF REPUBLIC ACT 7160 OTHERWISE KNOWN AS THE LOCAL GOVERNMENT **CODE OF 1991.**

WHEREAS, for legislative action by the sanggunian is the appointment issued by the Municipal Mayor Hon. Edgar S. San Luis of Mr. Rogelio A. Cruz, Jr. as Municipal Budget Officer effective February 17, 2025, for confirmation/ concurrence;

WHEREAS, Section 454 (d) of RA 7160 provides that heads of departments and offices shall be appointed by the Municipal Mayor with the concurrence of the majority of the Sangguniang Bayan members, subject to Civil Service Laws, Rules and Regulations;

WHEREAS, the aforementioned was referred to the Committee on Good Governance, Public Ethics and Public Accountability for its deliberation;
