RESOLUTION NO. 085-S2025

A RESOLUTION AUTHORIZING THE HONORABLE MAYOR EDGAR S. SAN LUIS TO SIGN AND ENTER INTO A MEMORANDUM OF AGREEMENT ON BEHALF OF THE MUNICIPAL GOVERNMENT OF SANTA CRUZ, LAGUNA, WITH THE PROVINCE OF LAGUNA REPRESENTED BY THE PROVINCIAL GOVERNOR, HON. RAMIL L. HERNANDEZ FOR THE FUND ASSISTANCE TO BE UTILIZED EXCLUSIVELY FOR THE PROJECT "TOURISM DEVELOPMENT PROGRAM"

WHEREAS, a copy of Memorandum of Agreement (MOA) was endorsed by the Honorable Municipal Mayor Edgar S. San Luis to this august body with the purpose as stipulated in the above-mentioned title of this resolution;

WHEREAS, the Municipality of Santa Cruz, Laguna has been identified by the Province of Laguna as an active partner in the delivery of key services to the constituents of Laguna. As such, the Municipality of Santa Cruz, Laguna proposed the implementation of a Community Development Program;

WHEREAS, the Memorandum of Agreement (MOA) will cover fund assistance amounting to Five Hundred Thousand Pesos (P500,000.00) to be utilized exclusively for the project "Tourism Development Program";

WHEREAS, this Memorandum of Agreement (MOA) is of significant importance as the proposed project of the Municipality of Santa Cruz, Laguna is recognized and supported by the Provincial Government of Laguna, and the Province further recognizes the capability of the Municipality of Santa Cruz, Laguna in active participation in the implementation of national programs and projects;

WHEREAS, the said request was discussed and deliberated by the members of the Committee on Tourism of this sanggunian;

WHEREAS, after a careful study and deliberation of the said committee, this body found its importance in providing essential services to the citizens;

WHEREAS, the said agreement is binding and should be implemented accordingly.

NOW THEREFORE, on motion of the Hon. Mark Anthony M. Juangco (Chairman of Committee on Tourism), duly seconded by all the members present, it was

RESOLVED: To authorize the Honorable Mayor Edgar S. San Luis to sign and enter into a Memorandum Agreement on behalf of the Municipal Government of Santa Cruz, Laguna, with the Province of Laguna represented by the Provincial Governor, Hon. Ramil L. Hernandez for the fund assistance to be utilized exclusively for the project "Tourism Development Program".

ORDERED: Let copies of this resolutions be furnished the Hon. Mayor Edgar S. San Luis, the Municipal Administrator, the Municipal Accountant, the Municipal Budget Officer, the Municipal Treasurer, the Municipal Planning and Development Coordinator, the Municipal Information and Tourism Office, Hon. Governor Ramil L. Hernandez, Laguna Tourism Culture Arts and Trade Office (LTCATO), and all others concerned, for their information and appropriate action.
