A RESOLUTION AUTHORIZING THE HONORABLE MAYOR EDGAR S. SAN LUIS TO SIGN AND ENTER INTO A MEMORANDUM OF AGREEMENT ON BEHALF OF THE MUNICIPAL GOVERNMENT OF SANTA CRUZ, LAGUNA, WITH THE LAGUNA STATE POLYTECHNIC UNIVERSITY REPRESENTED BY ITS UNIVERSITY PRESIDENT, MARIO R. BRIONES, EdD.

WHEREAS, a copy of the Memorandum of Agreement (MOA) was endorsed by the Honorable Municipal Mayor Edgar S. San Luis to this august body with the purpose as stipulated in the abovementioned title of this resolution;

WHEREAS, the attached Memorandum of Agreement (MOA) between the Laguna State University and the Municipal Government of Santa Cruz, Laguna pertains to an extension project known as LIVÉ (Livelihood and Innovative for Valued Environment) for LIFE (Learning, Inspiring, Fulfilling and Evolving) the Sounds of the Future;

WHEREAS, the said request was discussed and deliberated by the members of the Committee on Livelihood. Trade and Industry of this sanggunian;
