## **RESOLUTION NO. 099-S2025**

A RESOLUTION AUTHORIZING THE HONORABLE MAYOR EDGAR S. SAN LUIS TO SIGN AND ENTER INTO A MEMORANDUM OF AGREEMENT IN BEHALF OF THE MUNICIPAL GOVERNMENT OF SANTA CRUZ, LAGUNA, WITH THE PHILIPPINE STATISTICS AUTHORITY FOR THE USE OF THE BATCH REQUEST SYSTEM (BREQS).

WHEREAS, a copy of the Memorandum of Agreement (MOA) was endorsed by the Honorable Municipal Mayor Edgar S. San Luis to this august body for the purpose as stipulated in the above-mentioned title of this resolution;

WHEREAS, the Philippine Statistics Authority (PSA) has implemented the Civil Registry System Information Technology Project (CES-ITP) to serve as service points for the decentralized processing of requests for Civil Registry Documents;

WHEREAS, as part of this project, the PSA has established Online Civil Registry System (CRS) outlets throughout the Philippines and offers the Batch Request System (BREQS) to provide an offline method of encoding requests for Civil Registry Documents and submitting them to the PSA's online CRS Outlets;

WHEREAS, after a careful study and evaluation of the said agreement, by the concerned body, it was deemed proper to grant an authority to the Municipal Mayor Edgar S. San Luis to sign and enter into an agreement with the Philippine Statistics Authority to provide its constituents with easier access to Civil Registry services;

WHEREAS, the said agreement is binding and should be implemented accordingly.

NOW THEREFORE, on motion of the Hon. Esmeraldo C. De Las Armas, Jr. (Chairman of the Committee on Good Governance, Public Ethics and Public Accountability), duly seconded by Hon. Norman T. Tolentino, Hon. Rizaldy N. Kalaw and Hon. Alan T. Pamatmat and with the approval of the members of the Sangguniang Bayan present, it was

RESOLVED: To authorize the Honorable Mayor Edgar S. San Luis to sign and enter into a Memorandum of Agreement in behalf of the Municipal Government of Santa Cruz, Laguna, with Philippine Statistics Authority for the use of the Batch Request System (BREQS).

ORDERED: Let copies of this resolution be furnished the Hon. Mayor Edgar S. San Luis, the Municipal Administrator, the Municipal Accountant, the Municipal Budget Officer, the Municipal Treasurer, the Municipal Planning and Development Coordinator, the Municipal Local Civil Registrar, Philippine Statistics Authority and all others concerned, for their information and appropriate action.
